- Maintain detailed operational records for compliance and auditing.
- Identify and engage auditors for verification.
- Plan and manage third-party audits.
- Oversee permanent plant production and annual reporting.
- Liaise with the Clean Energy Regulator on compliance and reporting obligations.
- Deliver agent services for carbon project stakeholders.

- Establish and manage an Australian National Registry of Emission Units (ANREU) account.
- Select and implement methodologies under the Carbon Credits (Carbon Farming Initiative) Act 2011 (Cth) for land-based revegetation and forest regeneration projects.

- Model land-based methodologies using FullCAM for ACCU projections and reporting.
